Also present Doug Heath, Town Attorney and Kurt VanWycke, Hwy Supt..

Following roll call and the Pledge of Allegiance, the minutes of September 10, 2019 were approved, motion by Mr. Woolston second by Mrs. Yockel and carried

Mr. Fitzak gave an update on the REDI committee.

Under privilege of the floor Mrs. Dobson of Erway Tract spoke in regards to Modern disposal refusing to go down private fire lanes to pick up garbage. Discussion followed.

Mrs. Klein of Sunset Parkway stated that there are many fire lane signs missing in her neighborhood.

Mr. Elsner of Jones Beach Dr. asked if there were any informational packets handed out of what can and can't be placed in the recycle bins.

Mrs. Montulli of Kirkwood along with other town residents expressed their concerns regarding chickens being kept at their properties. She stated that the zoning does not allow this and wants the Town Laws enforced.

Peg Wiley of Wileys Marina read a letter regarding Lake Ontario Resiliency and Economic Development Initiative (REDI) to the Town Board. Discussion Followed

George Lacey of Captains Cove expressed his concern if the Town representatives on the REDI committee acted in the best interest of all town stakeholders. Discussion followed.

A motion by Mr. Fitzak to approve the Supervisors report was seconded by Mr. Woolston and carried.

A motion by Mr. Gifaldi to approve the Town Clerk report was seconded by Mr. Woolston and carried.

A motion by Mr. Fitzak to approve the Code/Zoning report was seconded by Mr. Gifaldi and carried.

A motion by Mrs. Yockel to approve Justice Hurley's report seconded by Mr. Fitzak and carried.

A motion by Mr. Woolston to approve Justice Russel's report seconded by Mrs. Yockel and carried.

Mr. VanWycke gave an update on Water and Highway activities.

The Carlton Fire Company responded to 21 Calls at a total of 105 man hours in the month of September. Chief Niederhofer stated that the Meat raffle will be held on November 1<sup>st</sup> at the rec hall.

A motion by Mr. Woolston to approve the vouchers in the Amount of \$ 212,926.94 second by Mr. Fitzak and carried.
